

The Ministry will thereafter set up an institutional framework in a period of 3 months i.e. 30.09.2014 to achieve the objective of inter-linking of rivers rather than making piecemeal efforts.</p> <p><b>(Description- Ministry of Water, RD &amp; GR-Summary Record of discussion of the meeting taken by the Prime Minister to review the Departments/Ministries.)</b></p>	<p>In order to revisit various reports available on Inter linking of rivers including report of Task Force on ILR(2002) under Shri Suresh Prabhu, M.P., another Task Force on ILR under Chairmanship of Shri B.N.Navalawala, Chief Advisor MoWR,RD&amp;GR has been constituted on 13.04.2015 and its work is in progress.</p> <p>Further as per decision of Hon'ble Supreme Court, March 2012, a Special Committee on ILR under Chairmanship of Hon'ble Minister(WR,RD&amp;GR) has been constituted on 23.09.2014.</p> <p>The Special Committee on ILR and Task Force on ILR is deliberating objective of Inter Linking of Rivers in a consultative manner.</p> <p>14 meetings of Special Committee and 9 meetings of Task Force have been held so far.</p>
