Para-1	As per records, 19 Consultants have been appointed in NWDA since 2006 till March 2018.
Para-2	Four (04) Consultants were appointed after retirement from NWDA.
Para-3	This information is not readily available. The same is being collected from field offices where these Consultants were posted. After receipt of the same, it will be sent.
Para-4	The qualifications and experience were decided from case to case basis. NWDA engaged these consultants to deal with the workload relating to special committee of Interlinking of Rivers, various clearances related to the Interlinking of River Projects and Administration/Accounts work.
Para-5	The consultants were appointed as per provisions laid down under General Financial Rules- 2015 as amended from time to time.
Para-6	Month wise work done by the Consultants are put up by them to their controlling officers on the basis of which the remuneration released.
Para	As per RTI Act, 2005, the CPIO is expected to provide the information
7 to 9	which he/she possess and not to create the information.
Para-10	Due publicity was given in Local/National Newspapers and website of NWDA to engage the consultants in various fields.
