Subject: - Submission of Immovable/Annual Property Return (IPR/APR) for the year 2020 (as on 31.12.2020) by all Officers/Employees, NWDA in eHRMS - reg.

In terms of Rule 18 of CCS (Conduct) Rules, 1964, the Immovable/Annual Property Return is required to be furnished by all officers/employees, NWDA, latest by 31.01.2021. IPR/APR should be submitted by all officials through eHRMS. Print copy of the same (IPR/APR submitted online) duly signed by official, should also be submitted to Director (Admn.)/Chief Vigilance Officer, NWDA, which is the custodian of Immovable/Annual Property Return (IPR/APR) of all employees.

2. It is, therefore, requested that all Officers / Employees, NWDA may be directed to file their Immovable/Annual Property Return (IPR/APR) for the calendar year 2020 (as on 31.12.2020) on or before 31.01.2021, through eHRMS only. IPRs/APRs received beyond the stipulated date, shall not be regarded as conforming to the extant guidelines. It is also stated that last date of filing of IPR/APR is 31.01.2021.
