

Point-1	During the year 2019, 25 posts (21-UR, OBC-02, SC-1 and ST-01) of Junior Engineer was advertised.
Point-2	The offer of appointments were issued, based on the rank (category-wise) obtained by the candidates for the vacancies in the said category. A list of the same enclosed at annexure-I.
Point-3	The panel has already been expired on 30.11.2020.
Point-4	The validity of the penal one year which is extendable for further six months. In the instant case, the result was declared on 21.05.2019. Thus the penal was validated upto 20.05.2020. However, with the approval of Competent Authority the same was extended upto 30.11.2020.
