ORDER

WHEREAS, Ms. Sudha Saxena (Appellant) 58, Lucky Home Apartment, Sector-13, Rohini, Delhi-110085 vide her RTI applications both dated 24.07.2017 and 16.10.2017 had sought the following information:-

1. Whether the revised Pay Scale (Rs. 15600-39100/-+5400 GP, PB-3) of the post of Assistant Director (OL)/Hindi Officer is implemented in the Autonomous Bodies under your Ministry as per 6<sup>th</sup> CPC.
2. If yes, the certified copy of order may be provided.
3. Whether the approval Ministry of Finance/Ministry of Home Affairs (Deptt. Of Official Language) Governing Body of the Organization has been obtained to implement the revised Pay Scale as per 6<sup>th</sup> CPC for the post of Assistant Director (OL)/Hindi Officer in the Autonomous Bodies under your Ministry.
4. If yes, the certified copy of Order/Letter/Noting regd. the approval of Ministry of Finance/Ministry of home Affairs (DOL)/Governing Body of the Organization may be provided.
5. Whether any letter received from the Autonomous Bodies under your Ministry to implement the revised Pay Scale as per 6<sup>th</sup> CPC for the post of Assistant Director (OL)/Hindi Officer.
6. If yes, the certified copies of letters may be provided.
7. What is the Pay Scale of Assistant Director (OL)/Hindi Officer before and after the 6<sup>th</sup> CPC may be given.

2. Whereas, the Director (Admn.) & CPIO has replied the RTI application vide letter No. 12/27/2017-Admn./11692-93 dated 09.08.2017 and letter No. 12/27/2017-Admn./18138-40 dated 09.11.2017.

3. Whereas, the Appellant is not satisfied with the reply given by the CPIO and requested for providing the following information:-

**Para No.5:** Whether any letter or noting sent from your office to your Ministry to implement the revised pay scale as per 6<sup>th</sup> CPC for the post of Assistant Director (OL)/Hindi Officer.

**Para No.6:** If yes, the certified copy of the letter or noting may be provided.



4. Whereas, the undersigned has examined the Appeal dated 07.11.2017 with reference to her RTI applications both dated 24.07.2017 and 16.10.2017 and reply vide letter No.12.27/2017-Admn./11692-93 dated 09.08.2017 and letter of even number dated 09.11.2017 given by the Director (Admn.) & CPIO. The information given by the CPIO is in order as per provisions contained in RTI Act 2005 and there is no need to issue any direction to the CPIO in this regard.

5. Whereas, the information sought under para 5 of Appeal dated 07.11.2017 is different as of para 5 of RTI application dated 16.10.2017. However, in the interest of justice, a copy of letter dated 27.05.2011 sent to the Ministry of Water Resources, for upgradation of post of Hindi Officer in NWDA, is being provided and enclosed.

6. In case the Appellant is not satisfied with the above reply, she can prefer second appeal with the Central Information Commission.
