Paras	Reply
Para-1, 2 & 3	You have asked for detailed information regarding processing of your representations/Appeal made during the period from 19.1.1993 to 22.1.2016. The representations were not sent to NWDA Headquarters directly but through Chief Engineer (South), NWDA, Hyderabad/ Executive Engineer, Investigation Division, NWDA, Bangaluru. Providing of such 25 years old and detailed information would disproportionately divert the limited resources of the concerned establishment. Hence the same is denied under section 7(9) of RTI Act, 2005. However you are free to inspect the available record as per mutually convenient date and time.
Para-4	You have not mentioned the details of persons and when they were appointed by NWDA. So, it is not possible to provide this information.
Para-5	Narmada Central Authority and National Water Development Agency are different organizations/entity. NWDA is not supposed to follow the rules/ regulations followed by other Department. In respect of Establishment/Personnel matters, the Nodal Department for National Water Development Agency is Ministry of Water Resources, River Development & Ganga Rejuvenation /DOPT.
Para-7 & 8	CPIO is supposed to provide information in the form it is available but not to examine further and comments on the findings of Selection Committee. So, it is not possible to provide information against these paras.
