Implemented</p>	<p>It may be mentioned here that NWDA does not make any allocation of water to any State. Based on the allocation of water by the respective Water Tribunals, NWDA has planned the links taking into account the requirement of the basins/areas. While carrying out studies for inter basin water transfer, NWDA has followed the guidelines framed by the TAC of NWDA.  The inter basin water transfer links are based on the surplus water available at diversion points and are aligned to run by gravity to the extent possible and by lift in small reaches such that lift does not exceed 120 m. The quantity of water indicated in the link proposals are based on the irrigation requirements in each basin State and utilisable quantity of water. Inter basin water transfer proposals are formulated on the basis of techno-economic viability and the studies are carried out considering the basin as a hydrological unit. The upland areas in some States could not be covered due to involvement of high lift. Hence the arrangement of utilisation in u/s States was proposed by substitution.</p>
