5/3	<p>The Ministry will revisit various reports available on inter-linking of rivers including the Suresh Prabhu Committee. The Ministry will thereafter set up an institutional framework in a period of 3 months i.e. 30.09.2014 to achieve the objective of inter-linking of rivers rather than making piecemeal efforts.</p> <p><b>(Description- Ministry of Water, RD &amp; GR-Summary Record of discussion of the meeting taken by the Prime Minister to review the Departments/Ministries.)</b></p>	<p>The Union Cabinet while approving the constitution of Special Committee for ILR in its meeting held on 24<sup>th</sup> July, 2014 directed that a committee comprising of experts be constituted to look into the issues relating to inter linking of rivers. In compliance to the direction of Union Cabinet, MoWR, RD &amp; GR vide O.M. dated 13<sup>th</sup> April, 2015 has constituted a Task Force for Interlinking of Rivers (TF-ILR) under the Chairmanship of Shri B.N.Navalawala, Chief Advisor, MoWR, RD&amp;GR. Task Force is assisting the Special Committee for ILR and MoWR, RD &amp; GR regarding implementation of ILR Programme.</p> <p>Seven meetings of the Task Force have been held so far and the last meeting was held on 11.05.2017. Work of Task Force is in progress.</p>
