Circular

It has been observed that Employees of NWDA have been submitting medical claims towards the treatment taken from the Private clinic/ hospitals for reimbursement. It necessitated to clarify that all Employees of NWDA may take treatment from their AMAs not more than the days restricted in NWDA medical Rules (i.e. maximum 20 days), and, if, further treatment is required for the same disease beyond the stipulated days, they may get themselves refer from the AMAs to Govt. Hospital/ CGHS empaneled hospitals or the hospitals recognized by the NWDA i.e. St. Stephen Hospital. Similarly diagnostic tests for reimbursement is admissible only from Govt. Hospitals/ CGHS empaneled diagnostic centers/hospitals or the hospitals recognized by the NWDA i.e. St. Stephen Hospital. The list of the approved AMAs for Delhi NCR and also for the field Units may be taken from the Ministry of Health & Family Welfare website which are updated from time to time. In the absence of the same, individual may approach to the Doctor for AMAs fulfilling the criteria mentioned for the AMAs in NWDA medical Rules and in the absence as per the guidelines of CSMA Rules. The approved diagnostic centers list may also be taken from the same i.e. MoH&FW.
