<u>परिपत्र</u>

In continuation to NWDA's Circular No. 10/1/2025-Admn./(i)/701-39 dated 30th January, 2025, it is further clarified that the monetary limit for the claim of medical reimbursement(OPD) will be applied as per the date of medical bill in a particular year. No claim of bill will be further extended in the limit of next year or previous year monetary limit. Further, at a time in a bill maximum three months' medicine can be purchased and reimbursed. If in any particular case, medical experts/doctor prescribed medicine for more than three months, it can be bifurcated on three months' basis and can be claimed in next year monetary limit.

2. Only the bills from CGHS empanelled hospital/Government recognized hospital or the hospital recognized by the NWDA or the bills from AMA will only be admissible for reimbursement from the monetary limit of the particular year.

3. In case of acute emergency such as accidents or life threatening emergency, when there is no nearby CGHS recognized or Government Hospital or NWDA recognized hospital is available within 8 km periphery, the bill of private medical hospital may be reimbursed for a short period (Maximum 1 or 2 days) with proper emergency certificate which will be restricted as per CGHS/CS(MA) rate.
