

Applications are invited for one post of Chief Engineer (Level-I), National Water Development Agency (NWDA) in Level-14(Rs. 144200 -218200/-) of pay matrix to be filled **by deputation (including short term contract)**. NWDA is an Autonomous Body registered under the Society Registration Act, 1860 under the D/o Water Resources, River Development & Ganga Rejuvenation, Ministry of Jal Shakti. The Chief Engineer (Level-I), NWDA is responsible among other things for maintaining and safe custody of sensitive data in respect of Himalayan & Peninsular Component, for exercising administrative control and providing technical direction and guidance to the Superintending Engineers to assist the Director General in implementing the various programmes and policy directions relating to studies on Peninsular/Himalayan Components.

(b)(i) Possessing degree in Civil Engineering from a recognized University or equivalent

ii) experience in applied research in the field of irrigation and water utilization and/or experience in surveys, investigations, designs, preparation of irrigation project, construction, operation and maintenance of irrigation projects/works.

Note:

1. The departmental Chief Engineer (Level -II) with two years regular service in the grade will also be considered and in case he is selected for appointment to the post, the same shall be deemed to have been filled up by promotion.
2. The departmental Officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
