Minutes of 13thmeeting of the "Group on Financial Aspects under Task Force for Interlinking of Rivers" for Interlinking of Rivers" held on 25.07.2018 in the Committee Room of NWDA, Palika Bhawan, New Delhi.

The Thirteenth meeting of the "Group on Financial Aspects under Task Force for Interlinking of Rivers" was held under the Chairmanship of Dr. Prodipto Ghosh, former Secretary to Govt. of India and Chairman of the Group on 25.07.2018 (Wednesday) at 11.30 A.M. in the Committee Room of NWDA, Palika Bhawan, New Delhi. Item 13.1: Confirmation of minutes of the Twelfth Meeting of the Group on Financial Aspect held on 12.07.2018

The Group deliberated upon the note and suggestion were made with respect to WPI assumption figures and cost on account of Technical uncertainties for arriving at total ILR program cost. Further Group also asked YES Bank team to provide Impact on Central Government fiscal deficit considering that all cost of ILR program is raised as debt.

YES BANK team was advised to incorporate YBL workings in line with the discussions into the "Interim Report of Finance group of Task Force on ILR" and share the same for finalization.

Item 13.3: Detailed discussion on the draft of Interim report

The Member – Secretary informed that the draft interim report was circulated to all the members/special invitees on 23rd July, 2018 by e-mail. Based on the input given by various members the report has been modified and presented in the meeting. The draft

report was discussed in detailed by the Group and the changes/corrections suggested by the Members were carried out.

Some portion of report related to funding of ILR projects, External Assistance funding etc. is to be modified by Dr. Tulasidhar. He assured to provide the modified version of the related portion of the report to Member secretary on 26.07.2018. Similarly, the Yes Bank team is to provide input for the report by 27th July, 2018.

It was decided that considering the input provided by the members in the meeting and also the input likely to be provided by Yes Bank team and Dr. Tulasidhar, the Member – Secretary will modify the draft report and circulate to all members/special invitee by the end of the July, 2018.
