EVENT BY INDIA-EU WATER PARTNERSHIP

An objective session on India-EU Water Partnership was held to contribute on the shared vision by India and the EU for a sustainable management of water resources and tackling the challenges posed by water management in the context of growing population, competing water demands and climate change. The session aimed to contribute with possible ways on Water Security for Sustainable Development with Equity.

The India- EU Water Partnership is an outcome of the 'Joint Declaration on India- EU Water Partnership adopted by the EU and Government of India during the 13th EU-India Summit. The EU and India have agreed to scale up cooperation on water management in the framework of the EU-India Water Partnership, notably to tackle water pollution in line with the water-related Sustainable Development Goals and underlined the importance to address water challenges in the context of climate change.





EVENT BY INTERNATIONAL ORG. WORLD BANK

On the 4th Day of "7th India Water Week", an exciting session took place that covered the talk on Technology and Innovation in Water Management by the International Organization World Bank. The session was chaired by Ms. Sumila Gulyani, World Bank and co-chaired by Ms. Eileen Burke, World Bank. It highlighted on Global Platforms and tools for Water Assessment, Emerging Disruptive Technologies for Hydro-informatics, River Basin Planning and Innovative Water Planning and management in India. After the insightful and enthralling session, a discussion round took place for 15 minutes.

EVENT ON MANAGING WATER RELATED DISASTERS - FLOODS AND DROUGHTS.

A thought-provoking, enthralling seminar was organized on the "7th India Water Week" on the topic Managing Water Related Disasters- floods and droughts. The session was chaired by Prof. R Nagarajan, CSRE, IIT-Bombay & co-chaired by Sh. M.K Srinivas, Chairman, GFCC. The seminar covered mathematical presentation on Channel Routing, Basin Management Model focusing on decision making, accuracy of run-off estimates, best way to set reservoir releases and water abstractions from river water intake structures.
